## **1. Acceptance of Terms**

## 7. Payment Terms

Skycheon offers subscription services at the following rates:

Monthly Subscription: \$99 per month

Lifetime Access: \$299.99 (one-time fee)

**Payment Method:** Payments can be made using major credit cards, debit cards, or through secure online payment platforms specified on our website. All payments will be converted to USD, so do keep that in mind.

**Billing Cycle:** For monthly subscriptions, the billing cycle begins on the date of subscription and will recur monthly on that date. For lifetime access, a one-time payment is made at the time of subscription.

**Automatic Renewal:** Monthly subscriptions are automatically renewed each month. Subscribers will be charged the applicable fee using the payment method on file.

**Cancellation Policy:** Subscribers may cancel their monthly subscription at any time. However, cancellation requests must be made at least 48 hours before the next billing cycle to avoid being charged for the next month. Lifetime subscriptions are non-refundable and non-transferable.

**Refunds:** Refunds for monthly subscriptions will be considered on a case-by-case basis and are subject to management approval. Refund requests must be submitted within 7 days of the billing date. As mentioned, lifetime subscriptions are non-refundable.
